EXECUTIVE SUMMARY

The following summary is qualified in its entirety by reference to the more detailed information included in the Offering Memorandum of the Fund, as amended or supplemented from time to time (the "Offering Memorandum"), elsewhere in this Supplemental Offering Memorandum and the Memorandum and Articles of Association (collectively the "Articles of Association") of All Metrics Asset Management SPC. This summary does not purport to be complete and should be read in conjunction with such additional detailed information. Words and phrases used in this Supplemental Offering Memorandum shall, unless otherwise provided, have the same meanings as are ascribed to them in the Offering Memorandum.

Base Currency The base currency of the Sub-Fund is U.S. Dollars (US\$).

- Business Day A day other than a Saturday or Sunday on which banks in Uruguay, New York, United Kingdom ("UK") or the Cayman Islands are open for normal banking business and any alternative or additional days designated as a Business Day by the Directors.
- Classes of Shares: Subscribers may subscribe through this Supplemental Offering Memorandum for non-voting, participating shares classified as Class M Shares, Class I Shares or Class R Shares (each a "Share Class"), each denominated in US dollars. Each Class has different rights attributable thereto and a distinct Net Asset Value.
- Closing Date The last day of the Initial Offering Period.
- Custodian Gletir Corredor de Bolsa S.A. will act as custodian to safe keep the fund's account and maintains its custody account with Bank of New York, a top tier service provider in a segregated account.
- **Distribution Fees** The Sub-Fund will pay Pershing LLC a distribution fee each calendar quarter in respect of each Share Class subscribed through Pershing LLC. The fee is up to 0.30% per annum of the total assets subscribed by Pershing LLC and shall be calculated and accrued on each Valuation Day.

The Sub-Fund will pay Allfunds a distribution fee each calendar quarter in respect of each Share Class subscribed though Allfunds. The fee is 0.07% per annum of the total assets subscribed by Allfunds plus a fixed fee up to $\leq 3,333.33$ for the first year, $\leq 5,000.00$ for the second year and $\leq 6,666.66$ thereafter. These fees shall be calculated and accrued on each Valuation Day.

- **Dividends** The Sub-Fund does not intend to declare dividends to Shareholders.
- **Expenses** Those fees of the Fund allocated by the Directors to the Sub-Fund on a pro-rata basis where appropriate, including but not limited to the Director's fees, legal expenses and government fees as well as those expenses incurred by the Sub-Fund including but not limited to management fees, administrative fees, brokerage fees and banker fees (see "Fees and Expenses").

Fees

Management Fee

The Investment Manager is entitled to receive a quarterly Management Fee, as set out in the table below, based on the Net Asset Value attributable to the relevant Share Class up to:

Class R Shares	5.00%

The Investment Manager charges each Share Class a Performance Fee equal to 10% of the amount by which the Performance of the Sub-Fund attributable to each Share Class exceeds the Benchmark for the relevant Fee Period, accrued monthly and payable to the Investment Manager in arrears as soon as practicable after the end of each Fee Period.

The Performance Fee is calculated independently by the Administrator. If the Performance of the Sub-Fund attributable to each Share Class is positive but does not exceed the Benchmark in any Fee Period then no Performance Fee shall be paid. The Sub-Fund is not required to earn back this shortfall from the Benchmark in order for future Performance Fees to be paid. If the Sub-Fund attributable to each Share Class shall have negative Performance in any Fee Period then no Performance Fee shall be paid in subsequent Fee Periods until the Sub-Fund attributable to the respective Share Class has generated sufficient Performance to exceed the negative Performance brought forward from prior Fee Periods.

Performance is defined as the amount by which the Net Asset Value of the Sub-Fund attributable to the respective Share Class at the end of the Fee Period exceeds the Net Asset Value of the Sub-Fund attributable to each Share Class at the beginning of the Fee Period as adjusted for additions to and withdrawals from the Sub-Fund attributable to the respective Share Class.

Net Asset Value is defined as the aggregate net realized and unrealized gains and losses on investments from the Sub-Fund's portfolio and net income from operations (before Performance Fee accrual) attributable to the respective Share Class.

Benchmark is defined as the pro-rata annualized rate of appreciation in the Net Asset Value equal to 8%.

Fee Period is defined as the period ending on the last Valuation Day of a calendar year and commencing on the day following the Valuation Day in the previous calendar quarter. The first Fee Period commenced on the first Business Day of operation and the last Fee Period shall end on the last day of operation. A Fee Period is calculated as actual days on a 365 day basis.

Advisory Fee

The Investment Advisor will not charge the Sub-Fund any fees.

Administration Fee

The Fund will pay the Administrator a fee as set out in the Administration Agreement.

The Administrator, in addition, will charge the Sub-Fund a fee for the provision of support services relating to the US Foreign Account Tax Compliance Act ("FATCA") and the Common Reporting Standard, collectively "AEOI", board support services, anti-money laundering services and communication expenses as set out in the Administration Agreement.

INTRODUCTION

This Supplemental Offering Memorandum relates to the offer of Shares in All Metrics Argentina Recovery Fund SP, a segregated portfolio of All Metrics Asset Management SPC (the "Sub-Fund").

The Fund may from time to time create additional sub-funds as the Directors determines in their discretion. Details of any sub-funds already created or created in the future will be as set out in a separate supplemental offering memorandum. Since the Fund constitutes a single legal entity, sub-funds within the Fund do not constitute legal entities separate from the Fund.

Gletir Corredor de Bolsa S.A serves as the investment manager (the "Investment Manager") to the Sub-Fund. The Investment Manager is responsible for monitoring the Sub-Fund's investment operations.

This Supplemental Offering Memorandum relates to the continuous offering of Class M Shares, Class I Shares, and Class R Shares, each with par value of US\$0.01 per Share.

Investment Objective

The Sub-Fund will aim to achieve long term capital appreciation by investing in a diversified multi asset class portfolio.

The Investment Manager is responsible for complying with the Investment Objective and Strategies as set out herein.

Investment Policy and Objective

The Sub-Fund's investment objective is to achieve absolute rates of return superior to traditional Latin American indices principally through investments in sovereign, sub-sovereign and corporate securities related to issuers in Argentina. The Sub-Fund will hold a concentrated portfolio of fixed income and equity investments, by investing in a range of liquid and illiquid publicly traded financial instruments including, without limitation, equity and fixed income securities, futures, options, money market, term deposits, foreign exchange and securities of multinational companies with meaningful interests in Argentina, regional tracking stocks, and similar vehicles. The Sub-Fund will be able to invest up to 25% of its Net Asset Value in other listed securities.

Investment Program

Due to the high historical volatility in global financial markets, and Argentina in particular, the Sub-Fund has been given broad investment parameters so that it can elect portfolio components that best capitalize on the prevailing market conditions. While the Sub-Fund's objective is to achieve high absolute total returns, it is also concerned with the preservation of capital. The Investment Manager will seek to achieve the Sub-Fund's objectives by investing in a concentrated selection of liquid and illiquid publicly traded financial instruments including, without limitation, equity and fixed income securities, futures, options, money market deposits and foreign exchange. The Sub-Fund may invest in both US Dollar and non-US dollar denominated securities. The Sub-Fund may build significant cash balances at different moments to navigate market volatility.

Argentina's market dislocation has opened up significant valuation opportunities. Argentina's economic and capital market's backdrop has undergone a period of stress and dislocation since the end of April 2018 that has triggered significant capital outflows, a devaluation of the Argentine peso from 20 per dollar to 57 per dollar and the decline in the country's fixed income instruments ranging from approximately 40% to 55%. The largest driver of this volatility and asset depreciation has been Argentina's the political risk associated with national election cycle including the 2019 presidential election that is set to take place on October 27th. Argentina's Merval stock index has lost 73% of its value in USD dollars since the all-time high reached on February 2, 2015. The Investment Manager believes that this environment has created deeply distressed valuations for equities and debt instruments.

Approach

The Investment Manager will employ a multidisciplinary approach combining in-depth fundamental analysis with a set of technical tools to enhance market-timing decisions. In pursuing its investment objectives, the Investment Manager will emphasize the following:

(i) Fundamentals - Directional long positions in corporate securities will be focused on companies with sequential momentum in sales, margins and cash flow that have been "oversold" or whose performance has trailed that of other comparable companies in the same sector. Active due diligence on quarterly and annual earnings announcements, underlying growth measures and sector drivers will complement relative valuation work. Fundamental analysis will also seek to identify equity mispricing from mergers, asset disposals, and changes in capital structure. The ability to recognize global sector trends before they impact equity prices in Latin America may help investors outperform traditional market indices.

(ii) Macroeconomic & Fiscal Data Analysis -The Investment manager has an extensive database of macroeconomic and fiscal data that will be used to evaluate investment opportunities and risks for sovereign, sub-sovereign and corporate debt. These tools extend to regulatory frameworks, tax collection

architecture and expenditure models that can help ascertain debt sustainability fundamentals for individual issuers and the Argentina sovereign.

(iii) Technicals -This refers to a security's historical trading patterns and prices. The Sub-Fund will employ quantitative tools such as funds flow movements, relative strength indicators, correlation and other metrics to take decisions on investment timing.

(iv) Perception - This refers to the propensity of investors to take decisions based on often erroneous or exaggerated perceptions. In Argentina, market volatility rises from time to time when perceived modifications in macroeconomic risk result in a generalized market downturn or a rally that leads to temporary overvaluation. The Investment Manager will seek to identify and capitalize on transitory periods of excessive value dislocations and other temporary periods of market inefficiency.

Investment Focus

The Sub-Fund's investment focus will include multinational companies with significant exposure in Argentina. The Sub-Fund will also invest in the securities of publicly listed companies that have meaningful investments in Argentina. The Investment Manager will invest in the shares of companies with Latin American operations which the Investment Manager regards as meaningful including tracking stocks, bonds, parent company securities, futures and options. The Sub-Fund is also permitted to sell investments short, and this may occur if the Investment Manager determines that an event is likely to have a negative impact on the market price of an issuer's securities or if the position may reduce the risk inherent in taking long positions. There are no strict limits to short selling, which will be used principally, but not specifically to hedge long positions, and its use will depend upon the Investment Manager's strategy and assessment of the market's direction. Credit analysis determinations as to eligibility for investment will be made by the Investment Manager based on publicly available information, if any, and enquiries made of the issuing entities. Assets in which the Sub-Fund is invested may not be rated, and, whether or not rated, such obligations generally will have speculative characteristics. Although the Investment Manager is not required to do so.

The Sub-Fund may not employ leverage. The Sub-Fund may hedge any foreign exchange risk.

If the Investment Manager considers this to be in the best interest of the Shareholders, and notably for defensive purposes on a temporary basis, the Sub-Fund may also hold up to 100% of its net assets in liquidities such as (but not limited to) cash deposits, money market funds and money market instruments.

The business of the Fund includes the realisation and distribution of the Sub-Fund's assets to Shareholders during a wind down of the Sub-Fund's operations.

The strategies employed for the Sub-Fund are speculative and entail substantial risks. No assurance can be given that the Investment Objective of the Sub-Fund will be realised. See "Risk Factors and Special Considerations" below and "Risk Factors" in the Offering Memorandum.

RISK FACTORS AND SPECIAL CONSIDERATIONS

There is a substantial risk of sustaining losses in the aforementioned investment strategy. Therefore, only prospective investors who have both the requisite knowledge and are financially secure should consider investing in the Sub-Fund.

The Fund relies on each investor to obtain independent and qualified investment and tax advice before purchasing Shares in the Sub-Fund.

Investment Manager

The Sub-Fund has appointed Gletir Corredor de Bolsa S.A to serve as the investment manager of the Sub-Fund (in such capacity, the "Investment Manager"). The Investment Manager has discretionary powers, under the terms of an investment management agreement between the Fund, on behalf of the Sub-Fund, and the Investment Manager ("Investment Management Agreement") to invest the assets of the Sub-Fund and ensure compliance with and valuation of the assets of the Sub-Fund in accordance with this Supplemental Offering Memorandum.

The Investment Manager is an independent asset management company, based in Montevideo, Uruguay, and also has regional presence in Uruguay. Founded in 2003, it specialized in advising its individual and institutional clients in the management of their assets and their global financial planning. The Investment Manager develops products and services that contribute to the protection and heritage diversification of its clients.

The directors of the Investment Manager are Juan Maria Terra, Orlando Francisco Parisi and Diego de Achaval. Their biographies are set out below.

Juan María Terra

He has a long professional trajectory in the financial markets industry. He worked at BankBoston Uruguay (now Banco Itaú) in the area of Back Office – Currency and Capital Markets from 1997 to 2003.

From 2003 to present, he is a director, the Compliance Officer and Administrative Operational Manager of Gletir Corredor de Bolsa S.A.

Orlando Francisco Parisi

He graduated from Universidad Nacional de Buenos Aires as a certified public accountant.

He started his career in the financial markets in 1973 for several firms based in Argentina, Brazil, Chile and Uruguay. He joined Gletir Corredor de Bolsa S.A. in 2019 and presently he is a director of the company.

Diego de Achaval

He has a bachelor's degree in banking management from the University of Buenos Aires, Argentina.

He has more than 25 years of professional experience in recognized financial institutions, including, among others, BankBoston Uruguay (now Banco Itaú), HSBC and Commercial Bank in Uruguay.

Since 2003 he is Director and business structuring manager of Gletir Corredor de Bolsa S.A.

Investment Advisor

The Investment Manager has appointed Mr Walter Stoeppelwerth and Mr Joaquín Bagües to serve as the investment advisor of the Sub-Fund (in such capacity, the "Investment Advisor"). Under the terms of the investment advisory agreement between the Investment Manager and the Investment Advisor ("Investment Advisory Agreement" and together with the Investment Management Agreement, the "Investment Management and Advisory Agreements"), the Investment Advisor shall provide information and advice to the Investment Manager with respect to the selection and monitoring of the Company's investments.

Walter Stoeppelwerth: Mr Stoeppelwerth has an MBA in Finance from Kenan Flager School, University of North Carolina, Chapel Hill and a BA in History from Duke University. He has 28 years of experience in the areas of research and portfolio management for emerging markets, occupying positions of Analyst as

well as Director of Research and Strategist in Latin America based in Argentina and Brazil. He worked for 12 years in New York, where he was the co-portfolio manager of the Tiedemann Investment Group's long/short fund of emerging markets and two other groups from 2002 to 2014. He has published extensively on the economic challenges in emerging markets, with an emphasis on how financial instruments react to adjustment plans in countries such as Argentina, Brazil, Turkey, Mexico and South Africa. Today, he is Chief Investment Officer of Portfolio Personal Inversiones SA, where he leads a research team covering macroeconomics, fixed income and equities, in addition to his role as CIO for the area of investment funds.

Joaquín Bagües: Mr Bagües has a MSc in finance from Universidad Torcuato Di Tella (UTDT) and a BA in Business Economics from Universidad Austral. He worked at KPMG Argentina as a Deal Advisory Consultant analyzing M&A operations, business restructuring and developing business strategy for local and international corporate clients. Later on, he joined Balanz Capital in 2015 and served as the Head of Emerging Market Funds. Additionally, he works as an academic advisor and professor of macroeconomics at the Austral University. In 2019, he joined Portfolio Personal Inversiones as Head of Strategy.

Investment Management and Advisory Agreements

The Investment Management and Advisory Agreements are terminable at any time by the Fund on behalf of the Sub-Fund in the event that the Investment Manager or the Investment Advisor, in the reasonable judgement of the Directors, shows reckless disregard, wilful misfeasance, bad faith or gross negligence in the performance of its obligations and duties under the Investment Management Agreement or the Investment Advisory Agreement. The Investment Management and Advisory Agreements are also terminable by either party on 90 days' notice or sooner with the written consent of both parties.

The Investment Management and Advisory Agreements provide that the Fund, on behalf of the Sub-Fund, will indemnify the Investment Manager or Investment Advisor (as applicable) from all liabilities whatsoever which the Investment Manager or Advisor may incur in performing their obligations under the Investment Management or Advisor Agreements, other than those liabilities resulting by reason of any fraud, gross negligence or material breach of duty in respect of the Investment Manager or the Investment Advisor's duties under the Investment Management Agreement or the Investment Advisory Agreement (as applicable).

The Investment Manager or Advisor agree to indemnify, defend and hold harmless the Fund on behalf of the Sub-Fund, its Directors, officers, employees and controlling persons and affiliates against any and all costs, losses, claims, damages or liabilities, joint or several, including, without limitation, attorneys' fees and disbursements, judgements and amounts paid in settlement actually and reasonably incurred by him as a result of any act or omission of the Investment Manager or Advisor relating to the Sub-Fund if there has been a final judicial or regulatory determination or, in the event of a settlement of any action or proceeding, to the effect that such acts or omissions violated the terms of this Subscription Agreement or involved fraud, gross negligence or material breach of duty on the part of the Investment Manager other than liabilities resulting from the Investment Manager or Advisor implementation of any express directions of the Directors.

If the Investment Management Agreement or the Investment Advisory Agreement is terminated, the Directors shall convene a shareholders' meeting to appoint a new Investment Manager or Investment Advisor (as applicable) by shareholders' resolution.

The Investment Manager also has the authority to select and appoint one or more sub-managers for the Fund's investment activities (each a "Sub-Manager"), which may include an affiliate of the Investment Manager, to delegate to such Sub-Manager(s) any or all of the Investment Manager's authorities, powers, rights, and duties under the Investment Management Agreement subject always to the Investment Manager's general supervision. The Investment Manager shall compensate the Sub-Manager from the fees it earns from the Sub-Fund in its capacity as Investment Manager.

<u>Banker</u>

MUFG Union Bank, N.A. ("MUFG") will serve as banker to the Sub-Fund. MUFG is a full-service bank with offices across the United States and is a member of Federal Deposit Insurance Corporation.

MUFG is a member of the Mitsubishi UFJ Financial Group (the "Group"), one of the world's largest financial organizations, headquartered in Tokyo and with approximately 350 years of history and a global network of 1,100 offices in over 49 countries and regions. The Group has over 140,000 employees and about 300 entities.

MUFG's shares trade on the Tokyo, Nagoya, and New York (NYSE: MTU) stock exchanges.

MUFG shall have no responsibility to initiate, appear in, prosecute or defend any legal proceeding relating to any property held by it in its capacity as banker to the Sub-Fund under its respective agreements with the Fund, for and on behalf of the Sub-Fund. MUFG shall have no responsibility to initiate any proceeding or engage the services of any third party for the collection of overdue amounts owing to the Sub-Fund in connection with its services under these agreements. If, at the request of the Fund, MUFG agrees at its discretion to appear in, prosecute or defend any such legal or equitable proceeding, either in its own name or in the name of its nominee(s), the Fund, on behalf of the Sub-Fund, will first indemnify MUFG (from the assets of the Sub-Fund) to its satisfaction against damages and expenses (including attorneys' fees) which may be sustained or incurred by it in so acting.

<u>Custodian</u>

Gletir Corredor de Bolsa S.A. (in such capacity, the "Custodian") holds agreements with top tier leading entities to offer its clients worldwide custody services. The Sub-Fund will safe keep its assets in a segregated account under the agreement that the Custodian holds with Bank of New York.

The Custodian has no responsibility to initiate, appear in, prosecute or defend any legal proceeding relating to any property held by them in their capacity as the Sub-Fund's custodian under its respective agreements with the Fund for and on behalf of the Sub-Fund. The Custodian has no responsibility to initiate any proceeding or engage the services of any third party for the collection of overdue amounts owing to the Sub-Fund in connection with their services under these agreements. If, at the request of the Fund, the Custodian agree at its discretion to appear in, prosecute or defend any such legal or equitable proceeding, either in their own name or in the name of its nominee(s), the Fund for and on behalf of the Sub-Fund will first indemnify the Custodian to its satisfaction against damages and expenses (including attorneys' fees) which may be sustained or incurred by them in so acting.

The Sub-Fund may choose to add additional custodians in the future at the discretion of the Investment Manager in consultation with the Directors.

FEES AND EXPENSES

Investment Manager's Fees:

The Investment Manager is entitled to receive a quarterly Management Fee, as set out in the table below, based on the Net Asset Value attributable to the relevant Share Class up to:

Class M Shares	2.00%
Class I Shares	3.00%
Class R Shares	5.00%

The Investment Manager charges each Share Class a Performance Fee equal to 10% of the amount by which the Performance of the Sub-Fund attributable to each Share Class exceeds the Benchmark for the relevant Fee Period, accrued monthly and payable to the Investment Manager in arrears as soon as practicable after the end of each Fee Period.

The Performance Fee is calculated independently by the Administrator. If the Performance of the Sub-Fund attributable to each Share Class is positive but does not exceed the Benchmark in any Fee Period then no Performance Fee shall be paid. The Sub-Fund is not required to earn back this shortfall from the Benchmark in order for future Performance Fees to be paid. If the Sub-Fund attributable to each Share Class shall have negative Performance in any Fee Period then no Performance Fee shall be paid in subsequent Fee Periods until the Sub-Fund attributable to the respective Share Class has generated sufficient Performance to exceed the negative Performance brought forward from prior Fee Periods.

Performance is defined as the amount by which the Net Asset Value of the Sub-Fund attributable to the respective Share Class at the end of the Fee Period exceeds the Net Asset Value of the Sub-Fund attributable to each Share Class at the beginning of the Fee Period as adjusted for additions to and withdrawals from the Sub-Fund attributable to the respective Share Class.

Net Asset Value is defined as the aggregate net realized and unrealized gains and losses on investments from the Sub-Fund's portfolio and net income from operations (before Performance Fee accrual) attributable to the respective Share Class.

Benchmark is defined as the pro-rata annualized rate of appreciation in the Net Asset Value equal to 8%.

Fee Period is defined as the period ending on the last Valuation Day of a calendar year and commencing on the day following the Valuation Day in the previous calendar quarter. The first Fee Period commenced on the first Business Day of operation and the last Fee Period shall end on the last day of operation. A Fee Period is calculated as actual days on a 365 day basis.

Investment Advisor's Fee

The Investment Advisor will not charge the Sub-Fund any fees.

Administration Fee

The Fund will pay the Administrator a fee as set out in the Administration Agreement.

The Administrator, in addition, will charge the Sub-Fund a fee for the provision of AEOI support services, board support services, anti-money laundering services and communication expenses as set out in the supplements to the Administration Agreement.

Further, the Administrator will charge a one time, set-up fee of US\$500 for each subscriber which invests directly into the Sub-Fund and not through a recognised financial institution acting on its behalf as a nominee. The fee will be deducted from the subscription amount of the relevant subscriber.

Distribution Fees

The Sub-Fund will pay Pershing LLC a distribution fee each calendar quarter in respect of Shares subscribed through Pershing LLC. The fee is to up to 0.30% per annum of the total assets subscribed by Pershing LLC and shall be calculated and accrued on each Valuation Day.

The Sub-Fund will pay Allfunds a distribution fee each calendar quarter in respect of each Share Class subscribed though Allfunds. The fee is 0.07% per annum of the total assets subscribed by Allfunds plus a fixed fee up to €3,333.33 for the first year, €5,000.00 for the second year and €6,666.66 thereafter. These fees shall be calculated and accrued on each Valuation Day.

Director's Fees

The Sub-Fund shall pay no director's fees.

Banker Fees

MUFG will charge the Sub-Fund its standard fees for the range of services provided.

Statutory and Licence Fees

The Sub-Fund will be charged a portion of the Fund's annual statutory fee calculated on the nominal amount of the authorised share capital of the Fund, which is currently the equivalent of US\$3,293 per annum for the Fund plus a fee of US\$366 specific to the Sub-Fund. In addition, the Sub-Fund will be charged a portion of the Fund's annual mutual fund licence fee which is currently the equivalent of US\$4,269 per annum plus a fee of US\$305 specific to the Sub-Fund.

Organisation Costs

The Sub-Fund will assume a portion of the Fund's costs and expenses associated with the organisation of the Fund and plus the setup costs and expenses associated with the Sub-Fund. Refer to the "Fees and Expenses" section of the Offering Memorandum of the Fund.

SIDE LETTERS

The Investment Manager hereby informs all investors and prospective investors that it has entered into and may in the future enter into side letters with investors or prospective investors subscribing for shares in the Sub-Fund, whereby certain investors, for various reasons, may receive discounts on redemption and subscription charges, management fees and or performance fees in the Sub-Fund. Such discounts will vary on a case by case basis, but may be up to 100% of either or a combination of management fees, performance fees, subscription and redemption charges.

USE OF PROCEEDS

Proceeds received by the Sub-Fund from the issue of Shares, after the holding back of any reserves, are used for investment in accordance with its Investment Strategies and for operating expenses of the Sub-Fund.

ANTI-MONEY LAUNDERING OFFICERS

Pursuant to the Anti-Money Laundering Regulations (as amended) of the Cayman Islands, the Fund must designate natural persons to act as its Anti-Money Laundering Compliance Officer, Money Laundering Reporting Officer and Deputy Money Laundering Reporting Officer (the "**AML Officer Roles**"). The Directors have ensured that natural persons have been designated to perform the AML Officer Roles in accordance with Cayman Islands law. Subscribers can obtain further information in respect of the AML Officer Roles from the Directors or the Investment Manager.

Account Holder means the person listed or identified as the holder of a Financial Account by the Financial Institution that maintains the account. A person, other than a Financial Institution, holding a Financial Account for the benefit or account of another person as agent, custodians, nominee, signatory, investment advisor, or intermediary, is not treated as holding the account for purposes of this Subscription Agreement, and such other person is treated as holding the account. For purposes of the immediately preceding sentence, the term "Financial Institution" does not include a Financial Institution organized or incorporated in a U.S. Territory. In the case of a Cash Value Insurance Contract or an Annuity Contract, the Account Holder is any person entitled to access the Cash Value or change the beneficiary of the contract. If no person can access the Cash Value or change the beneficiary, the Account Holder is any person named as the owner in the contract and any person with a vested entitlement to payment under the terms of the contract. Upon the maturity of a Cash Value Insurance Contract or an Annuity Contract, each person entitled to receive a payment under the contract is treated as an Account Holder.

Non-U.S. Entity means an Entity that is not a U.S. Person.

Substantial U.S. Owner (as defined in Regulations section 1.1473-1(b)) means generally:

- (a) With respect to any foreign corporation, any Specified U.S. Person that owns, directly or indirectly, more than 10 percent of the stock of such corporation (by vote or value);
- (b) With respect to any foreign partnership, any Specified U.S. Person that owns, directly or indirectly, more than 10 percent of the profits interests or capital interests in such partnership; and
- (c) In the case of a trust
 - i. Any Specified U.S. Person treated as an owner of any portion of the trust under sections 671 through 679 of the IRC; and
 - *ii.* Any Specified U.S. Person that holds, directly or indirectly, more than 10 percent of the beneficial interests of the trust.

U.S. *Person* means a U.S. citizen or resident individual, a partnership or corporation organized in the United States or under the laws of the United States or any State thereof, a trust if (i) a court within the United States would have authority under applicable law to render orders or judgments concerning substantially all issues regarding administration of the trust, and (ii) one or more U.S. persons have the authority to control all substantial decisions of the trust, or an estate of a decedent that is a citizen or resident of the United States. - b) the stock of the NFE is regularly traded on an established securities market or the NFE is a Related Entity of an Entity the stock of which is regularly traded on an established securities market;
- c) the NFE is a Governmental Entity, an International Organisation, a Central Bank, or an Entity wholly owned by one or more of the foregoing;
- d) substantially all of the activities of the NFE consist of holding (in whole or in part) the outstanding stock of, or providing financing and services to, one or more subsidiaries that engage in trades or businesses other than the business of a Financial Institution, except that an Entity does not qualify for this status if the Entity functions (or holds itself out) as an investment fund, such as a private equity fund, venture capital fund, leveraged buyout fund, or any investment vehicle whose purpose is to acquire or fund companies and then hold interests in those companies as capital assets for investment purposes;
- e) the NFE is not yet operating a business and has no prior operating history, but is investing capital into assets with the intent to operate a business other than that of a Financial Institution, provided that the NFE does not qualify for this exception after the date that is 24 months after the date of the initial organisation of the NFE;
- f) the NFE was not a Financial Institution in the past five years, and is in the process of liquidating its assets or is reorganising with the intent to continue or recommence operations in a business other than that of a Financial Institution;

- iv) the applicable laws of the NFE's jurisdiction of residence or the NFE's formation documents do not permit any income or assets of the NFE to be distributed to, or applied for the benefit of, a private person or non- charitable Entity other than pursuant to the conduct of the NFE's charitable activities, or as payment of reasonable compensation for services rendered, or as payment representing the fair market value of property which the NFE has purchased; and
- v) the applicable laws of the NFE's jurisdiction of residence or the NFE's formation documents require that, upon the NFE's liquidation or dissolution, all of its assets be distributed to a Governmental Entity or other non-profit organisation, or escheat to the government of the NFE's jurisdiction of residence or any political subdivision thereof.

Controlling Person means the natural persons who exercise direct or indirect control over an entity.

In the case of a trust, such term means the settlor(s), the trustees(s), the protector(s) (if any), the beneficiary(ies) or class(es) of beneficiaries, and any other natural person(s) exercising ultimate effective control over the trust, and in the case of a legal arrangement other than a trust, such term means persons in equivalent or similar positions. The term 'Controlling Persons' shall be interpreted in a manner consistent with the Financial Action Task Force Recommendations ("FATF").

FATF Recommendations on Controlling Persons:

Under Cayman Islands law, you have rights, and the Fund has obligations, with respect to your Personal Data. The purpose of this notice is to explain how and why the Fund, and persons engaged by the Fund, will use, store, share and otherwise process your Personal Data. This notice also sets out your rights under Cayman Islands law, and how you may exercise them.

In this notice, we use the following defined terms:

"Administrator" means JTC Fund Services (Cayman) Ltd;

"Personal Data" has the meaning given in the Cayman Islands data protection legislation (the "Data Protection Law, 2017"). Examples of Personal Data include an individual's name, address, email address, date of birth, passport details or other national identifier, driving licence number, national insurance or social security number, income, employment information, tax identifier and tax residence, account numbers, and economic information. It also includes data which, when aggregated with other data, enables an individual to be identified, such as an IP address and geolocation data;

"Processing" has the meaning given in the Data Protection Law, 2017. It is widely construed and includes obtaining, recording and holding data, as well as carrying out any operation on Personal Data, such as sharing, destroying and mining the Personal Data; and

"we", "us" and "our" in this notice refer to the Fund.

Who is providing this notice?

This notice is provided by All Metrics Asset Management SPC (the "**Fund**") for and on behalf of All Metrics Argentina Recovery Fund SP (the "**Segregated Portfolio**").

What role does the Fund perform in relation to your Personal Data?

The Fund acts as a **"data controller"** in respect of your Personal Data. This means the Fund is the decision maker as to the purposes, conditions and manner in which your Personal Data are processed, including:

- how to use, store, and process your Personal Data;
- with whom to share your Personal Data;
- when to modify or erase your Personal Data;
- when to engage one or more third parties to process your Personal Data; and

The Fund will continue to be data controllers even though it has engaged third parties, such as the Administrator, to perform certain of the processing activities on behalf.

Where do we obtain your Personal Data from?

• credit reference agencies; and

• fraud prevention and detection agencies and organisations, including law enforcement.

We may combine Personal Data that you provide to us with Personal Data that we collect from, or about you. This may include Personal Data collected in an online or offline context.

Why is your Personal Data processed?

- where required by tax authorities (who, in turn, may share your Personal Data with other tax authorities),
- our lawyers, auditors and other professional advisors for purposes of:
- providing you with investment-related services; and
- seeking advice on, and complying with, legal and regulatory requirements or legal rights and obligations.

In exceptional circumstances, we will share your Personal Data with regulatory, prosecuting and other governmental agencies or departments, and parties to litigation (whether pending or threatened), in any country or territory. We will not sell your Personal Data.

Do you have to provide us with this Personal Data?

Some of the Personal Data we request must be supplied for an investment in the Segregated Portfolio to be made, and for that investment in the Segregated Portfolio to continue. Some Personal Data must be supplied to us to enable the investment to be redeemed. If you do not wish to provide us with this Personal Data, you will not be able to invest in the Fund or the Segregated Portfolio as it will affect our ability to provide our services to you and manage your investment.

Sending your Personal Data internationally

Not all countries have data protection and privacy laws that provide you with the same or a comparable degree of protection as Cayman Islands law. Where we transfer your Personal Data to our service providers, including the Administrator and the Investment Manager, the Fund on behalf of the Sub-Fund will have in place a data protection policy and there will be data transfer agreements so as to provide your Personal Data with the same protections as exist under Cayman Islands law.

Retention and deletion of your Personal Data

We will keep your Personal Data for as long as it is required by us. For example, we may require it for our legitimate business purposes, to perform our contractual obligations, or where law or regulation obliges us to. We will generally retain your Personal Data throughout the lifecycle of the investment you are involved in. Some Personal Data will be retained after your relationship with us ends. We expect to delete your Personal Data (at the latest) once there is no longer any legal or regulatory requirement or legitimate business purpose for retaining your Personal Data.

Automated decision-making

We will not take decisions producing legal effects concerning you, or otherwise significantly affecting you, based solely on automated processing of your Personal Data, unless we have considered the proposed

processing in a particular case and concluded in writing that it meets the applicable Cayman Islands law requirements.

Your rights

You have certain data protection rights, including:

• the right to be informed about the purposes for which your Personal Data are processed;

- the right to access your Personal Data;
- the right to stop direct marketing;
- the right to restrict the processing of your Personal Data;
- the right to have incomplete or inaccurate Personal Data corrected;
- the right to ask us to stop processing your Personal Data;

• the right to be informed of a Personal Data breach (unless the breach is unlikely to be prejudicial to you);

- the right to complain to the Data Protection Ombudsman; and
- the right to require us to delete your Personal Data in some limited circumstances.
